- Intended primarily for those who wish to carry out health research in Region VI
 - new in health research
- Will provide participants with knowledge and skills in health research proposal making

The Course

- Free of charge to participants
- Sure funding for one proposal requiring at most 200T and pass the evaluation criteria of the Research Management Committee and the Ethics Committee; to be funded by WVHRDC
- Research funds from CHD VI and DOST VI

Participants – the scholars

- From member institutions of WVHRDC
 - Faculty members
 - Personnel
 - Medical residents



Course Design and Approaches

- An intensive training course on making a proposal in health research.
- Consist of
 - Lectures
 - Oral presentations of research proposals
 - Mentoring

Course Design and Approaches

- Intensive classroom lecture topics
 - Research Methods
 - Statistical Analysis
 - Technical Writing





Mentoring

- The Human Resource Subcommittee assigns mentors to each scholar.
- Mentor scholar one-on-one meeting is organized at the end of each three scheduled classroom lectures.





Requirements

- Attendance to lectures
- Submission of draft version of proposal on a scheduled date just before the scheduled intensive lecture.
- Oral presentation of draft versions of the proposal
- Attendance to one-on-one meetings with mentors
- An acceptable research proposal for presentation and evaluation

Participants' Application

Requirements

- Letter of application addressed to Chair of WVHRDC
- Endorsement/nomination letter from WVHRDC-member institution
- Curriculum vitae (max of 4 pages)
- 2- page capsule proposal, describing the health problem the applicant would like to address
 - Should be in line with the health research priorities of the region.

Responsibility of the Nominating Institution

- The nominating agency will sign a contract with WVHRDC in behalf of the nominated successful applicant.
- When the scholar will not comply with requirements, the WVHRDC will be reimbursed for the training expenses incurred for the defaulting scholar.
